Protective gloves

Preventive skin protection by use of skin-protecting agents is recommended.

· Material of gloves

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be exactly calculated in advance and has therefore to be checked prior to the application.

As protection from splashes gloves made of the following materials are suitable:

Nitrile rubber (Ansell Sol-Vex®)

Recommended thickness of the material: $\geq 0.4 \text{ mm}$
